

Membership Levels

NOTE: Per Article V of the North Hills Hunt Bylaws: "All persons presented for membership in any classification shall have prior approval by the Board of Directors."

Gold Endowed Member — \$20,000 Lifetime Donation

Payable at \$5,000/year in consecutive yearly payments for four years. May be designated for a member of the Hunt community. Includes lifetime participation in all Hunt sporting and social activities for the donor and his dependents. The riding privileges are transferable to another person for the lifetime of the Endowed Member. Special recognition in the Club house, *Bugle* and Directory. Invitation to serve on the Permanent Fund Committee, upon completion of full payment for this membership.

Endowed Member — \$10,000 Lifetime Donation

Payable at \$2,000/year in consecutive yearly payments for five years. May be designated for a member of the Hunt community. Includes lifetime participation in all Hunt sporting and social activities for the donor and his dependents. The riding privileges are transferable to another person for a period of five years. Special recognition in the Club house, *Bugle* and Directory. Invitation to serve on the Permanent Fund Committee, upon completion of full payment for this membership.

Patron Member

Family — \$750***

*Introductory Family Patron — \$400***

Individual* (Single, unmarried person with no dependents) — \$650***

Introductory Individual Patron — \$300***

Members of the Hunt community, upon affirmative recommendation of two thirds of all members of the Board of Directors, shall be extended the honor and privilege of Patron Membership, which grants the member the privilege of full participation in all Hunt sporting and social functions, and other Hunt activities as the Board of Directors may determine from time to time.

Basic Member — \$300

Residents of the Hunt community, upon the recommendation of two or more members of the Hunt and the affirmative simple majority vote of the Board of Directors, shall be extended Basic Membership privileges. Basic members are encouraged to participate in all social and spectator functions of the Hunt, and other Hunt activities as the Board of Directors may determine from time to time. Basic Member capping shall be limited to the allotment per year as decided by the Board of Directors.

Affiliate Member — \$300

An Affiliate Membership may be granted to those individuals who are full riding members of another recognized hunt. It includes participation in Hunt sporting activities as determined by the Board of Directors, and social activities. Affiliate Members may not hold office or vote. Affiliate Member rides shall be limited to the allotment per year as decided by the Board of Directors.

Student Member — \$400

*Introductory Student — \$250***

Full-time, verifiable students under the age of 23, within the Hunt community may be extended the honor of Student Membership upon the recommendation of two Patron or Basic members and the affirmative simple majority vote of the Board of Directors. Student members shall enjoy the privilege of participation in all Hunt sporting and social functions and other Hunt activities as the Board of Directors may from time to time determine. A student member may not hold office nor vote. Membership privileges are personal to the student, and shall not be extended to their spouse and/or dependents or other household members.

Stable Professional Member — \$300

The proprietor, or lessee, if a North Hills Hunt member, of an established stable operation involving the boarding/training of horses shall designate one or more stable professionals, upon affirmative recommendation of two-thirds of all members of the Board of Directors. Stable Professional Memberships shall be allowed the full privileges of the North Hills Hunt at the basic membership rate. These privileges grant the member the full participation in all Hunt sporting and social functions; and other Hunt activities as the Board of Directors may determine from time to time. Riding privileges of the membership are personal to the professional and shall not be extended to their spouse and/or dependents or other family members. This membership does not include the proprietor and his/her household.

Clarification: *If barn owner or lessee and the professional are one and the same, only one fee would be assessed. Riding privileges of the membership are personal to the professional and shall not be extended to their spouse and/or dependents or other family members.*

* **Individual** By definition: a single, unmarried person with no dependents.

** **Introductory Memberships** are for those individual who are in their first year with the North Hills Hunt and who have not previously at any time been members of an organized hunt. There are no capping fees with this membership.

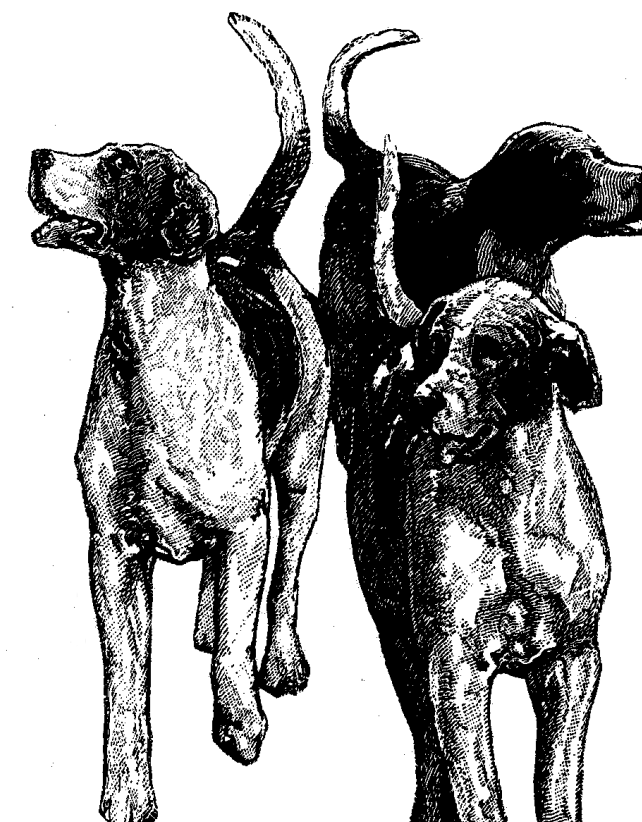

NHH Capping Fees



Formal Hunt Capping is \$40.00 per ride

Basic Member Capping is limited to an allotment per season as decided by the Board of Directors.

Guest Cappings are limited to Three (3) times per lifetime.

Each time you "ride" to the hounds constitutes a ride, whether capping is collected or not. Capping fee is not collected at cub hunting. Capping fee can be applied towards a membership upgrade.

Three Flights Planned on Formal Hunt Dates

FIRST FLIGHT: Jumping required. Proficiency of you and your horse to follow the hounds at a walk, trot, canter and gallop over varied terrain including natural and man made obstacles.
Object is to view working hounds.

SECOND FLIGHT: Some jumping required. Follows First Flight at walk, trot, canter over varied terrain. May jump or go around to nearest gate. Gates available at most coops. Easier route taken whenever possible.
Object is to view working hounds.

THIRD FLIGHT: No jumping. Walk, trot, canter over varied terrain—maybe some roading.
Object is to view working hounds.

Riders may move from one flight to the other by excusing themselves from their present flight with the Field Secretary or Field Master(s).
