Agreement for Release and Waiver of Liability for a Minor Child

To Be Executed by all Parents with Children Under Age of 19

I request permission for my child to participate in cross-country riding and foxhunting with the North Hills Hunt.

I fully understand that cross-country horseback riding and foxhunting (which includes riding over fences, other obstacles, and steep and rough terrain) are very dangerous activities. I wish to allow my child to participate in these activities knowing they are dangerous. I accept and assume all the risks of injury (including death) to my child or my property. I represent and warrant that I have the authority to sign this release and that I have instructed my child on the dangers of engaging in the above mentioned activities.

In exchange for my child being permitted to participate in these activities, for my child, myself, my child's heirs, guardians, and legal representatives, I release and agree not to make or bring any claim of any kind against the North Hills Hunt or its Masters, Officers, Directors, Members, Employees, Guests or any Land Owners, Landholders or other persons making property available for the North Hills Hunt, for any injury (including death), to my child or any damage to my property whether from anyone's negligence or not, or any other cause, arising out of my child's participation in these dangerous activities; and I also agree if anyone makes any claims because of any injury to my child (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims of whatsoever kind and nature.

Waiver and Release From Liability and Indemnity Agreement

In witness whereof the Undersigned has set his hand and seal:

In Consideration of being permitted to enter for any purpose, land owned, leased, rented, or borrowed for purposes of participating in hunt activities including riding over said lands on horseback, walking over said lands, or remaining in a stationary position to view hunt activities, the Undersigned for himself, his children under the age of 21 years, the Undersigned's guests and personal representatives, assigns, heirs, and next of kin, agrees and on the direct representation that he has, or will, prior to the inception of hunt activities, inspect such lands and he does further warrant that his participation in the scheduled hunt activities and his entrance upon said lands, constitute an acknowledgment that he has had the opportunity to inspect said lands and has either inspected said lands and found them to be safe and reasonably suited for the purpose of hunt activities or declines the opportunity to inspect said land and assumes all risk that said lands are not safe and reasonably suited for the purpose of hunt activities. I accept and assume all the risks of injury (including death) to me or my property.

- 1. Hereby releases, waives, discharges, and covenants not to sue or make any claim** against the Promoter, Hunt Association, Hunt Members, Staff, Guests, Owner or Owners of the land and each of the their heirs and employees, all for purposes herein referred to as Released from all liability to the Undersigned, his personal representatives, assigns, heirs, and next of kin for all loss or damage, and any claim or demand or otherwise while the Undersigned is upon said land: and
- 2. Hereby agrees to indemnify and save and hold harmless** the releases and each of them from any loss, liability, damage, or cost he may incur due to any individual claim of the Undersigned, Undersigned's children or guests resulting from being in or about said lands and whether caused by the negligence of the Releases or otherwise, including, but not limited to attorney fees and court costs.

The Undersigned expressly agrees that the foregoing Release, Waiver, and Indemnity Agreement is intended to be as broad and inclusive as is permitted by the law of the state in which the hunt activities are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The Undersigned warrants the following statements are true and correct and understands that the Releases have relied on them entering into the foregoing Release, Waiver and Indemnity Agreement and in giving the Undersigned permission to enter the said lands.

The Undersigned agrees that:

- 1. No oral representations, statements, or inducements apart from the foregoing written agreements have been made.**
- 2. He assumes full responsibility and risk of bodily injury, death, or property damage due to negligence of Release or otherwise upon entering the said lands.**
- 3. He has read and voluntarily signs this release and waiver of all liability and indemnity agreement.**
